AACTE Federal Legislative Priorities

- FY 22 appropriations. Increased funding for:
 - Teacher Quality Partnership Grants
 - Special Education Personnel Preparation
 - Title II
 - Institute of Education Sciences
 - Hawkins Centers of Excellence
- Higher Education Act reauthorization
 - Expansion/revision of Title II: Teacher Quality Enhancement
 - TEACH grants: increased funding, easier to meet service requirements

Addressing Teacher Shortages

- ODE work on diversifying the teacher workforce
- Legislative/executive interest in programs to enhance the teacher pipeline and address overall teacher shortages
- Modification of substitute teacher requirements

P-12 Policies Impacting Teacher Preparation

- HB 322/327 (CRT bills) Identify "divisive" or "prohibited" content that may not be taught
- State Board of Education Amended Resolution 13
 - Resolution to promote academic excellence in K-12 education for each Ohio student without prejudice or respect to race, ethnicity, or creed
- HB 151 Replace Ohio Resident Educator program with local mentorship
- Teacher Licensure Collaborative focusing on Whole Child initiatives (SEL/PBIS/Trauma-Informed Practice)
