10:30 – Open Meeting Discussion Points

Margaret (Peggy) Kasten, Director, Ohio Resource Center presented “A Discussion Proposal for Regional Teaching/Learning Conferences” prepared by the Ohio Resource Center for Interested SUED Institutions. The for-discussion-only document was distributed to those in attendance.

During the lunch session members engaged in further discussion regarding the ORC proposal. Some of the questions and considerations raised by members were as follows:

- *How are services provided by ORC different from IMS and ESC’s?
- *Is it feasible to cover the “how” for each of the Standards in one day?
- *Should we market this as a train-the-trainer session (teacher leaders/curriculum specialists)?
- *Are there other practical ways to deliver the training geographically?
- *Are there ways for the ORC to focus on training needs of faculty?

Discussion of the proposal will be revisited at a future meeting.

Michael Smith, President, Ohio Association of Colleges for Teacher Education, presented the “new” OACTE Organizational Overview, which included the purpose of OACTE, the organizational focus (advocacy, professional advancement, inquiry) and structure with major roles and responsibilities and membership composition for the Board of Trustees, Leadership Council, and Committees. Paula Compton, Ohio Board of Regents, thanked members for participating in the survey and opened discussion regarding Tech Prep programs and TAG agreements from a statewide perspective. Paula expressed the need for assessment tools which are being developed by OSU. She reported that the

Chancellor wants to see more dually enrolled students; however, there is a need for dialogue around the topic of TAG courses on High School campuses or on college/university campuses for HS students. SUED deans “are okay with” offering the introduction course, and suggest general education courses rather than additional education courses, to maintain quality in courses. Deans expressed “strong reservations” about offering additional TAG education courses at the HS level.

Strategic Planning: Chair Middleton discussed the need for SUED to establish a process for establishing priorities for the next year. There is a clear need to continue to be engaged in implementation of key components in House Bill 1 (This includes Teacher Residency). However, other priorities must also be established. At the next SUED meeting, Deans Feyten and Mahoney will lead the group in a process to develop consensus on establishment of priorities.
