Approval of Minutes of March 5, 2020; Motion Chery; Second Jarrod; approved

Tom McGee: ODE -

- HB 197 language in the bill allowing a temporary license for students who have not passed their OAE exams. It won't be a single license; it will be a suite of licenses. These will become available on May 15, 2020. Applicants will apply, it will go to esigners and then back to ODE to issue. When the tests are up again and teachers want to go ahead and get their "full" license anytime in that year. They can choose the "advance" option to advance to the 4-year Resident Educator license. For the endorsement they will select endorsement.
  - Tom asked about whether the IHEs need two sign offs one for the temporary and then one for the 4-year. One signature was preferred.
- Background checks info changing every day. BCI is still processing background checks.
   People can go out to a site that is open they are still completing these in person.
   People can also print out a card out at home and order an ink pad roll their own. BCI will walk them through how to complete the process.
- Regarding all OAE tests YES APK, content, reading...whatever the license requires.
- The one-year temporary license also applies to endorsements.
- PRICE \$40.00 for one-year license.

## Update on Primary Pk-5

The ODE update from previous meetings remains unchanged. It is attached.

### **ODHE: Krista Maxson**

• The EPPs determine the completion criteria for the 50%, etc. Each EPP must create and sign off on the completion criteria. Discretion is given to individual universities to create these. Documentation for CAEP will be required to demonstrate that candidates met the requirements.

- Krista has drafted memos to as accreditors that accredit other programs such as counseling

  – Krista has drafted memos to these agencies, but there is no information at this time.
  - Frustration was expressed with the other accrediting bodies (such as CACREP)
    that have not responded with information for their constituents. Krista
    suggested that she would pose a question on one of her listservs about other
    accrediting bodies.
- EdTPA Dawn suggested that EPPs may require completion of fewer of the edTPA tasks during this crisis and the edTPA may need to be completed in a virtual environment.
  - A question came up about students who are asking to take the edTPA if their institution doesn't require it. It was suggested that students may take it, but their EPP requirements would not be affected by individual student decisions to take it "outside" of the EPP requirement.
  - Questions about the cut score came up, but those will be discussed at a later time. (37 was proposed for those tests with 15 rubrics, 32 for those tests with fewer rubrics such as World Languages.)
- Endorsements and Second licenses State Review only (rather than SPA review) is recommended. If CAEP reviews these, the cost for the CAEP site visit increases as they it would increase the number of site visitors to accommodate the additional reviews. (It was expressed that care be used with the term, "add on" as it is specific CAEP language – use "second license" instead.)
- Question of SPA vs. full State review Krista will be convening a committee to discuss questions on this item. Send Krista an email expressing your interest in participating.
- Test development for Media Arts and Drama have been put on hold.
- A question about P/F "grades" came up with regard to its impact on licensure. Will there be difficulties with a broadened P/F policy. Tom, from ODE responded that ODE only looks at credit, not grades. LPDCs may operate differently.
- SUED asked Krista to put something in writing about P/F. Since there is currently no guidance about P/F grades, Krista suggested it will take a long while and be a low priority issue. SUED withdrew the request.

  - Ed Standards Board to make sure that the Ed Standards has appropriate guidance in referring issues out to the Teacher Prep Subcommittee. Clarification and guidance may be necessary about WHEN they need to refer out specific items.
  - Tracy is a full member and serves on the subcommittee, Wendy is a subcommittee member (attends the meetings the full meetings, too)
  - OCTEO in October 22 & 23,
    - Theme: Bringing Play into Teaching
    - 2019 Ohio Teacher of the Year will be speaking
