OBR Update (Wendy Adams):

- o MRS Deadlines
 - Due May 29th: User Access Letter (with President's signature and the names of two representatives from the IHE to use CurricUNET)
 - Due June 30th: Program Finder Confirm the accuracy and currency of the programs listed on the OBR website
 - Due June 30th: Profile Summary Login to MRS and check for accuracy; send confirmation/corrections to Wendy Adams.
- o Preservice Surveys:
 - Teachers, Principals send names/emails to Wendy; surveys will be sent June
 15th
- o Program approval manual a link was sent in an email last week
 - Wendy will provide an additional link for the OBR alignment chart (an align chart for all the OH standards which is a required part of Program Report)
- o Pearson Results Analyzer new information released competency
 - level data (new tab that says competency; no candidate data in the competency) report only aggregate data for programs with more than 10 people; there is no way to identify where the students attend -- regional campuses or main campus)
- PreK Special Needs Program -- discussion of whether this endorsement may be offered at the undergraduate level (which would be different from the level indicated in the Guidance Document)

Comment: Coursework for initial licensure offered at the graduate level must be graduate level work.

ODE Update: No one from ODE was present; there was discussion about whom to contact to be sure that someone from ODE is present (in person or by phone) at SUED meetings to provide updates; Joann will contact Julia Simmerer and ask about a contact person

Response to CAEP (**Tammy Kahrig and Ginny Keil**): Discussion: we want to be perceived as partners and critical friends; we want our CAEP relationship to be collaborative rather than adversarial; we, as end-users, would like to assist them in working with us to meet our needs in more collaborative ways; It was suggested that the next step be a phone call wherein we suggest our two highest concerns for continued focus.

Next Steps: It was suggested that an article around Ohio's innovations published by AACTE would be an excellent outcome from this meeting; therefore, we will pursue recording the call.

Format - it was suggested that we prepare a one page document with links (Susan and Erica will prepare)

Praxis CORE State Data (Joanne Arhar): Discussion regarding the difference in the pass rates of Praxis CORE when compared to Praxis I, especially in Math; Several IHEs are using the Praxis CORE and the state cut-score; A study at Kent found there was no relationship between high school GPA and passing the Praxis CORE; Kent's study also found that there is a strong relationship between students at the remediation-free level (for example: ACT 22 or better or SAT of 1000 or better) and passing on the first attempt; Joann also mentioned that there is state data available that demonstrates pass-rates.

Several bills on the table related to assessment: Limiting time for assessment and

eliminating PARRC are on the table

Superintendent Ross supports PARRC; ODE does not want to abandon it yet (at least wants to see the results first)

Center for the teaching Profession (Charlotte Daniels):

Increases in meeting growth targets for TIF schools (low-performing)

Licensure Updates

Online licensing - a lot of changes have been made; can upload transcripts; the process is speedier;

Credential Review Board: People going off, new for new members

Looking for nominations for Ohio Teacher of the Year

Educator Effectiveness Updates - New requirement to retake the OAE test if rated as ineffective

RESA - looking at streamlining; need additional reviewers

School Counselor Standards will now be required (HB164)

7 New Standards for Professional Development

Grade Bands for MCE -- currently 4-9; recommended to be 4-8 (prompted by the issues with the assessments)

Special education (breaking it into grade bands); discussion about a low incidence endorsement - addresses the shortage and need for special education

Joann will ask ODE about which items they would like to have input from SUED (P-16 should be digging in to this issue together)

Comment: Superintendents -- it would be helpful to know the key issues IHEs are discussing with their superintendents

Ohio Alliance Committee (Cheryl Irish for John Henning): The Committee is currently working on a transition plan for the Ohio Clinical Alliance. We are planning on two new co-chairs for the Leadership Committee, one to replace Randy Flora (P-12 co-chair) and one to replace John Henning (higher education representative). We also plan to establish 3 design teams and their leadership.

Upcoming Meetings include:

- Leadership Committee meeting, tentatively scheduled for Monday, June 15th from 10am-12noon.
- Ohio Clinical Alliance Design Team Meeting 10am-2pm on Tuesday, June 23rd. The meeting will take place at Ohio Dominican in the Griffin Student Center. Email invitation will be extended to those who signed up at OCTEO. Others are welcome as well. Contact John Henning for more information.
- Ohio Clinical Experience Design Team Phone conference on April 13th and will meet again on Thursday, May 21st. Over 30 interviews of professional interns/ student teachers have been collected from around the state. Data analysis will be discussed at the May 21st meeting.
- CAEP State Alliance Conference May 18-20th. Interviews have been collected in Alabama, Oregon, Oklahoma, Ohio, Maryland, and Kentucky. Data analysis and performance-based assessments will be topics of discussion.
