Ohio Department of Higher Education (Jessica Mercerhill)

- If your program has not transitioned to P-5 continue to use the early childhood OAE; if you have transitioned to P-5, you will take APK P-3 (001), and Generalist Content test 1 and II (018 and 019, if these two are taken together, the cost is the same as 1 test) and Foundations of Reading till summer of 2021 (we hope); For Primary SPED, no change in the tests APK P-3 (001), Early childhood SPED (013), and Foundations of Reading
- Questions for ODHE:
 - o Are candidates expected to show immunization records prior to placements for field/clinical?
 - o Are candidates expected to take drug tests prior to placements?
 - Did the ESB approve the edTPA recommendation?
 - It will go on the State Board of Education agenda for next week. The performance-based aspect of the recommendation may be delayed by a month. Candidates will not be able to use this option until July 1, 2020.
 - Resident Educator at ESB?
